On behalf of Committee for Management of sports Infrastructure in Asansol Municipal Corporation Area.

It is notified for information that an open auction will be held on 12/02/2018 at 03.00 P.M. in the Executive Meeting Hall of Asansol Municipal Corporation for allotment of Parking Lot at Asansol Stadium near Galaxy Mall. The interested bidder shall deposit a sum of Rs. 30,000.00 along with attested copy of Voter Id Card in Cash section by demand draft in favour of Asansol Municipal Corporation latest by 08/02/2018 at between 11.00 a.m. to 3.00 p.m. as earnest money for this parking lot. The earnest money will be refunded to the unsuccessful bidder.

The bidder of each parking lot shall call his rate per day basis on or above (minimum 10% maximum 15% each call) the reserved rate fixed by the Asansol Municipal Corporation which is mentioned in the auction brochure available in Cash Section of the Corporation on payment of Rs. 310/-. Auction is valid for a period of twelve months (one year) to be reckoned from the date of allotment of the lot.

The highest bidder shall have to deposit the bid money for six months at a time for the lot as per measured area & location of the plots mentioned in the auction brochure. The second installment of bid money shall be deposited by the licensee one month prior to completion of six months from the date of issue of license failing which the license granted shall be treated as cancelled and the authority will go for fresh allotment. The name of the higher bidder will be declared at the close of all of each particular lot. In the event of failure to deposit the highest bid money by the first higher bidder within the next working day of the auction, the second highest bidder shall have preference to deposit the second highest bid money. Similarly in the event of the failure to deposit the second highest bid money by the second highest bidder within the next working day on the expiry of period of failure to deposit the money by the highest bidder, the next highest bidder (third highest) shall have preference to deposit the amount called by him within the next working day to be reckoned from the date of failure to deposit the money by the second highest bidder. It is specifically stated that no plea for extension of the stipulated period for deposit of money as stated above will be entertained. In case of failure to deposit the money by

the first, second and third highest bidder within the period as stated above, the earnest money deposited by him as against each particular lot shall stand forfeited.

The earnest money deposited by each successful bidder against the lots allotted to him shall thereafter be treated as security money. The security money will be returned after expiry of the period of allotment of parking lot without any interest. The defaulters in making payment of amount to the earlier allotment of parking lots shall not be allowed to participate in open auction.

The auction brochure is available in Cash Section of the Corporation on payment of Rs. 310/- from 05/02/2018 to 07/02/2018 at between 11.00 a.m. to 3.00 p.m.

The Asansol Municipal Corporation reserves the right to accept or reject any or all bids without assigning any reason whatsoever.
