It is notified for information that an open auction will be held on 20/04/2017 at 03.00 P.M. in the Executive Meeting Hall of Asansol Municipal Corporation for allotment of Lachhipur area total parking lot of area under one umbrella. The interested bidder shall deposit a sum of Rs. 1,00,000.00 alongwith attested copy of Voter Card ID in Cash section by demand draft in favour of Asansol Municipal Corporation latest by 18/04/2017 as earnest money for each parking lot. The earnest money will be refunded to the unsuccessful bidder. official reserve price for the bidding is fixed a Rs.25,00,000.00 (Twenty-five lakhs) only for total parking lot as a whole.

The bidder of each parking lot shall call his rate over and above the reserved rate fixed by the Asansol Municipal Corporation available in the auction brochure in Cash Section of the Corporation on payment of Rs. 1000/- for a period of 36 months (three year) to be reckoned from the date of allotment of the lot.

The highest bidder shall have to deposit the bid money at a time within (03) three hours of the completion of bidding of total area. The name of the higher bidder will be declared at the close of bidders of the lot. In the event of failure to deposit the highest bid money by the first highest bidder within the stipulated time of the auction, the auction will be cancelled. It is specifically stated that no plea for extension of the stipulated period for deposit of money as stated above will be entertained and failing to deposit, the E.M. will be forfeited.

The earnest money deposited by successful bidder against the lots allotted to him shall thereafter be treated as security money. The security money will be returned after expiry of the period of allotment of parking lot without any interest. The defaulters in making payment of amount to the earlier allotment of parking lots shall not be allowed to participate in open auction.

The rate of highest bidder will be valid for one year. After expiry of the stipulated time of one year renewed may be done on satisfactory. Service provided by the highest bidders after enhancement of 10/15% of the existing rates as per decision of the higher authority.

The auction brochure is available in Cash Section of the Corporation on payment of Rs. 1000/- from 17/04/2017 to 18/04/2017 at 11.00 a.m. upto 4.00 P.M.
