It is notified for information that an open auction will be held on 24. 04. 2017 at 03.00 P.M. in the Executive Meeting Hall of Asansol Municipal Corporation for issuance of License for collection of user charges and night parking charges for bus & mini bus per day at Asansol City Bus Stand/Burnpur Bus Stand, Asansol under Asansol Municipal Corporation. The interested bidder shall deposit a sum of Rs. 30,000.00 alongwith attested copy of Voter Card ID in Cash section by demand draft in favour of Asansol Municipal Corporation as earnest money. The earnest money will be refunded to the unsuccessful bidder.

The License Shall Collect user charges @ Rs. 10/- per day per bus at Asansol City Bus Stand & Burnpur Bus Stand and night parking charges @ Rs. 50/- per night per bus at Asansol City Bus Stand & Burnpur Bus Stand & details of which are available in the auction brochure in Cash Section of the Corporation on payment of Rs. 310/- for a period of twenty four months (two year) to be reckoned from the date of issuance of license.

The highest bidder shall have to deposit the bid money for six months at a time for the Bus stand mentioned in the auction brochure. The second installment of bid money shall be deposited by the licensee one month prior to completion of six months from the date of issue of license failing which the license granted shall be treated as cancelled and the authority will go for fresh auction. In the event of failure to deposit the highest bid money by the bidder within the next working day of the auction, the second highest bidder shall have preference to deposit the second highest bid money. Similarly in the event of the failure to deposit the second highest bidder within the next working day on the expiry of period of failure to deposit the money by the highest bidder, the next highest bidder (third highest) shall have preference to deposit the amount called by him within the next working day to be reckoned from the date of failure to deposit the money by the second highest bidder. It is specifically stated that no plea for extension of the stipulated period for deposit of money as stated above will be entertained. In case of failure to deposit the money by the first, second and third highest bidder within the period as

stated above, the earnest money deposited by him as against each particular Bus stand shall stand forfeited.

The earnest money deposited by each successful bidder against to him shall thereafter be treated as security money. The security money will be returned after expiry of license period without any interest. The defaulters in making payment of license fee shall not be allowed to participate in open auction.

The Asansol Municipal Corporation reserves the right to accept or reject any or all bids without assigning any reason whatsoever.
